

United States - 29 June 2015 - Island Fruit and Nut Trail Mix packaged under the Free Range Snack Co. Brand and certain lots of bulk macadamia nuts recalled due to possible salmonella contamination.

United States - 27 June 2015 - Specific sell-by dates of Goodies by Nature Raw Cashews 9oz recalled due to possible salmonella contamination.

United States - 26 June 2015 - Specific best-before dates of H-E-B Hamburger and Hotdog Buns recalled due to possible foreign matter contamination.

United States - 25 June 2015 - Specific best-before dates of Whole Foods Market Raw Macadamia Nuts recalled due to possible salmonella contamination.

United States - 23 June 2015 - A specific best-before date of Wish-Bone Ranch Salad Dressing recalled due to mislabelling and the subsequent undeclared presence of an egg allergen.

United States - 22 June 2015 - Specific UPC codes of Goodseed brand Soy Bean Sprouts and Mung Bean Sprouts recalled due to possible *Listeria monocytogenes* contamination.

United States - 22 June 2015 - All lots of Sour Caramel Apple Gum recalled due to the undeclared presence of a dairy allergen. The caramel flavouring ingredient in the gum contains a small amount of dairy.

United States - 20 June 2015 - Specific production dates of approximately 2,478lb of pork and beef products recalled due to possible *Listeria monocytogenes* contamination.

United States - 19 June 2015 - A specific UPC code of Champ's Sliced Crimini Mushrooms recalled due to possible *Listeria monocytogenes* contamination.

United States - 18 June 2015 - Phoebe Mote Blanco
White Corn Semoule De Mais Blanc recalled due to
the undeclared presence of sulphites.

United States - 17 June 2015 - Specific production dates of approximately 668,316lb of poultry products recalled due to misbranding and the subsequent undeclared presence of monosodium glutamate (MSG).

United States - 16 June 2015 - Specific production dates of approximately 25,380lb of pork sausage

products recalled due to the undeclared presence of a wheat allergen.

United States - 15 June 2015 - A specific establishment code of commercial-use beef leg bone extract and beef concentrate products that were produced in Australia and New Zealand recalled as these were not presented at the US point of entry for inspection.

United States - 15 June 2015 - A specific production date of approximately 36lb of pork products produced in Italy was recalled as it was not presented at the US point of entry for inspection.

United States - 12 June 2015 - Specific production dates of approximately 529lb of beef tongue products recalled as they may have been shipped with lingual tonsils still attached.

United States - 10 June 2015 - Specific batches of Garden Fresh Steakhouse Potato Salad recalled due to possible *Listeria monocytogenes* contamination.

United States - 10 June 2015 - Nice! Powdered Sugar Mini Donuts recalled due to receiving consumer complaints alleging that mould was observed on some products.

United States - 10 June 2015 - A specific UPC code of Natural Grocers brand Macadamia Nuts recalled due to possible salmonella contamination.

United States - 9 June 2015 - Specific sell-by dates of approximately 93,006lb of both raw and cooked stuffed chicken products recalled due to the undeclared presence of a wheat allergen.

United States - 8 June 2015 - Select lots of injectable products to the hospital/user level recalled due to the presence of visible foreign particulate matter observed during testing of retention samples.

United States - 6 June 2015 - Various production dates of approximately 11,670lb of chicken and turkey sausage products recalled due to misbranding. The chicken and turkey sausages were wrapped in hog and sheep casings that were not listed on the labels.

United States - 5 June 2015 - Various production dates of approximately 29,052lb of poultry and pork products recalled as the chicken sausages were wrapped in hog casings that were not listed on the labels. Hog casings may elicit allergic reactions in the rare cases of individuals known to be allergic to pork proteins.

United States - 4 June 2015 - Specific non-coded 7oz plastic bags of Best Brand Green Raisin (Sunderkhani) recalled due to the undeclared presence of sulphites.

United States - 4 June 2015 - All batches of smoked salmon, excluding Hot Smoked Salmon, recalled due to possible *Listeria monocytogenes* contamination.

United States - 4 June 2015 - Specific production dates of approximately 49,308lb of various pork sausage products recalled due to possible foreign material contamination.

United States - 3 June 2015 - 950 retail cases of the Gluten Free California Veggie Burger recalled due to the undeclared presence of a soy allergen.

United States - 3 June 2015 - A specific use-by date of 1,640lb of ground elk meat recalled due to possible E. coli O157:H7 contamination.

United States - 3 June 2015 - A specific production date of approximately 16,000lb of ground beef products recalled due to possible E. coli O157:H7 contamination.

United States - 1 June 2015 - A specific Hemisphere code of 14,000lb of Vietnamese LP Cashews recalled due to possible salmonella contamination.

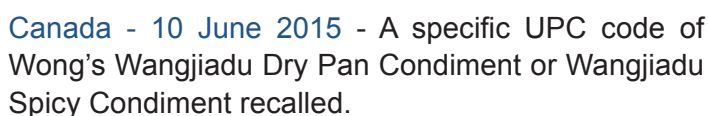
Australia - 19 June 2015 - A specific best-before date of Bakewell 12 Party Pies recalled due to possible foreign matter contamination (metal).

Australia - 18 June 2015 - Specific use-by dates of Ebuta Dairy Goats Milk Unpasteurised recalled due to possible E. coli contamination.

New Zealand - 17 June 2015 - A specific best-before date of Tasman Bay Herbs Ltd brand Italian Parsley 50g bags recalled due to possible *Listeria Monocytogenes* contamination.

Australia - 5 June 2015 - Specific best-before dates of Woolworths Select Chicken & Vegetable Pies 4pk recalled due to possible foreign matter contamination (glass).

Canada - 9 June 2015 - A specific UPC code of Live Organic Raw brand Garden Vegetable Crackers recalled due to the undeclared presence of a soy allergen.

Canada - 4 June 2015 - A specific UPC code of Goji Berry 150g recalled due to the undeclared presence of sulphites.

Germany - 26 June 2015 - A specific durability date of Seagold Schlemmerfilet Champignon recalled due to possible foreign matter contamination.

Denmark - 24 June 2015 - Specific expiry dates of First Price brand Ham Cubes, Ham Strips and Chicken Cubes, as well as COOP brand Ham Tern, Ham Strips and Chicken Strips recalled due to possible yeast growth.

Germany - 18 June 2015 - A specific expiry date of Geese Further Classic, Geese Further Lemon, Geese Further Orange, Geese Further Vital Grapefruit, Geese Further Lime, Mercury Classic, Mercury Orange, Mercury Lemon and Earl Burger Classic drinks recalled due to a defect on the bottle cap.

Germany - 17 June 2015 - A specific batch code of Maggi brand Chicken Broth 380ml glass jar recalled due to mislabelling.

Germany - 12 June 2015 - A specific batch code of Golden Fruit TK Strawberries and Golden Fruit TK Beerenmischung recalled due to possible Norovirus contamination. (Norovirus is also known as the winter vomiting bug).

Denmark - 12 June 2015 - A specific best-before date of Landsbyost 900g recalled due to the possible presence of mould.

Denmark - 12 June 2015 - Specific best-before dates of grated cheese recalled due to possible foreign matter contamination (small metal shavings).

Denmark - 1 June 2015 - Several types of minced meat recalled due to possible salmonella contamination.

Automotive & Pharmaceutical recalls

Australia - 26 June 2015 - A specific model year of Suzuki VZR1800 Boulevard motorcycles recalled due a possible defect on the rear backrest-mounting hardware kit(s).

Canada - 25 June 2015 - Specific model years of Chevrolet Sonic and Spark vehicles recalled as certain vehicles may fail to conform to Canada Motor Vehicle Safety Standard (CMVSS) 114 - Theft Protection and Rollaway Protection.

Australia - 23 June 2015 - Specific model years of Ducati Motorcycles recalled due to a possible defect on the internal nut retaining the piston to the rod, which might not be tightened to the specified torque.

Australia - 22 June 2015 - A specific model year of Kawasaki Ninja H2R (non-road category) Motorcycles recalled due to a possible defect on the harness on some units; this may be pinched or damaged between frame parts.

Australia - 22 June 2015 - All models of Alfa Romeo 4C recalled due to the passenger compartment interior window not having the required markings.

Australia - 19 June 2015 - A specific year model of Volkswagen Polo vehicles recalled due to a possible incorrect welding on the backrest frame of some vehicles; this may have been fitted on the front seats.

United States - 17 June 2015 - Specific model years of Mazda6 vehicles recalled as the driver front airbag may be susceptible to moisture intrusion and other factors.

Canada - 17 June 2015 - A specific model year of Jeep Cherokee vehicles recalled as certain vehicles equipped with a power liftgate may experience corrosion in the liftgate control module, which could result in an electrical short, potentially resulting in a fire causing injury and/or damage to property.

Canada - 16 June 2015 - A specific model year of Sebring vehicles recalled as, in the event of a collision that warrants a deployment of the front passenger airbag of certain two-door coupe vehicles, the deploying airbag could strike the passenger sun visor if it is in the down position.

Canada - 15 June 2015 - A specific model year of Ferrari Laferrari vehicles recalled due to a possible defect on the Tyre Pressure Monitoring System.

Canada - 15 June 2015 - A specific model year of Ferrari Laferrari vehicles recalled due to certain vehicles possibly not conforming to Canada Motor Vehicle Safety Standard (CMVSS) 202 - Head Restraints.

Canada - 15 June 2015 - A specific model year of Honda Accord vehicles recalled due to a possible defect on the passenger front airbag inflator.

Australia - 15 June 2015 - A specific model year of Carnival petrol and diesel variants recalled as a misalignment of the brake booster centre plate and assembly jig may have occurred and caused the O-ring in the brake booster to have been deformed.

United States - 15 June 2015 - Specific year models of Honda Accord vehicles recalled due to a defect on the dual-stage driver front airbag, which may be susceptible to moisture intrusion and other factors.

Australia - 15 June 2015 - A specific model year of Amarok vehicles recalled as the bolts for the front brake callipers on certain vehicles may not have been tightened with the specified torque.

United States - 12 June 2015 - All lots of Pyrola, 430mg/capsule recalled. Advanced Joint Formula capsules may contain undeclared diclofenac and chlorpheniramine.

Australia - 12 June 2015 - Specific amount of 45601-35070 RH Swivel Steering Arm - a product sold exclusively for Toyota Hilux vehicles - recalled as the steering arm ball may become loose in the steering arm.

Canada - 11 June 2015 - Specific model years of Land Rover Range Rover and Range Rover Sport vehicles recalled due to a possible defect on the door latch.

Australia - 11 June 2015 - Specific VIN numbers of Honda YM Accord and YM CR-V vehicles recalled as the Collision Mitigation Braking System (CMBS) may unexpectedly activate while operating the vehicle in certain driving conditions.

Australia - 10 June 2015 - Specific year models of Nissan Motor Co. (Australia) Pty Ltd—N16 Pulsar, Y61 Patrol, D22 Navara, J31 Maxima and T30 X-Trail recalled as the front passenger airbag inflator may

have been assembled with improperly manufactured propellant wafers.

Australia - 10 June 2015 - Specific year models of Nissan Motor Co. (Australia) Pty Ltd—N16 Pulsar, Y61 Patrol, D22 Navara, J31 Maxima and T30 X-Trail recalled as the front passenger airbag inflator may have been assembled with improperly manufactured propellant wafers. This is an amendment to the affected vehicles in the previous recall campaign that was launched globally in 2013 and 2014.

Australia - 10 June 2015 - Specific year models of Mazda6 (GG1031) Sedan, Mazda6 (GY1031) Wagon/Hatch, RX-8 (FE1031) Coupe, E-Series (SK) Van, T-Series (SY) Cab Chassis, B2500 (UN) Ute/Cab Chassis and B2600 (UN) Ute/Cab Chassis recalled as excessive internal pressure could be created in the inflator installed in the front driver airbag at the time of airbag deployment. As a result, the body of the inflator may rupture upon deployment.

Australia - 10 June 2015 - Specific year models of Mazda6 (GG1032) Sedan/Hatch, Mazda6 (GY1032) Wagon, Mazda6 Diesel (GG10R2) Hatch and Mazda6 Diesel (GY10R2) Wagon recalled as excessive internal pressure could be created in the inflator installed in the front passenger airbag at the time of airbag deployment. As a result, the body of the inflator may rupture upon deployment.

Australia - 10 June 2015 - Specific year models of Mazda6 (GG1032) Sedan/Hatch, Mazda6 (GY1032) Wagon vehicles recalled as excessive internal pressure could be created in the inflator installed in the front driver and passenger airbags at the time of airbag deployment. As a result, the body of the inflator may rupture upon deployment.



Germany - 5 June 2015 - A specific lot number of Medical Speciality foods NutriMax and Infatrini 500ml packs recalled due to possible salmonella contamination.

Canada - 4 June 2015 - Specific model years of Chrysler Town & Country, Dodge Grand Caravan and Journey vehicles recalled due to a defect on the Wireless Ignition Node (ignition switch).

Canada - 4 June 2015 - A specific model year of Nissan Murano vehicles recalled due to a possible defect with the Anti-Lock Braking System (ABS).

Canada - 4 June 2015 - Specific model years of Mazda6, RX-8 and MazdaSpeed6 vehicles recalled due to a possible defect on the driver front airbag inflator.

United States - 4 June 2015 - Specific year models of Mazda6 vehicles recalled due to a defect on the dual-stage driver front airbag, which may be susceptible to moisture intrusion and other factors.

Canada - 3 June 2015 - A specific year model of Cadillac CTS and ATS vehicles recalled as the bracket between the brake pedal assembly and the rod that actuated the vehicle service brakes may fracture.

United States - 3 June 2015 - 122 lots of Smart Lipo (800, 900, 950mg) capsules to the consumer level recalled. FDA received samples of 800 and 900mg capsules of Smart Lipo and the lab results found the products contained undeclared sibutramine, desmethyisibutramine and phenolphthalein.

Australia - 2 June 2015 - Specific model years of Dodge Journey and RT Chrysler Grand Voyager recalled as the Wireless Ignition Node (WIN) Module may move the Frequency Operated Button Ignition Key (FOBIK) from 'ON' to 'Accessory' position while driving.

Australia - 2 June 2015 - Specific model years of Jeep Cherokee and Jeep Wrangler vehicles recalled as a fatigued clutch interlock switch return spring could allow the driver to engage the engine starter motor without the clutch pedal being depressed. This could result in unintended vehicle movement and cause an accident without warning.

Australia - 2 June 2015 - Specific model years of LE Chrysler 300 vehicles recalled as the driver airbag inflator housing may rupture due to excessive internal pressure during normal airbag deployment events.

Australia - 2 June 2015 - A specific model year of Smart Fortwo vehicles recalled as the steering rack may have been secured to the vehicle cross member with incorrect bolts

Australia - 1 June 2015 - Four product codes of VASCU-GUARD Peripheral Vascular Patch recalled. Customer complaints were received regarding difficulty in distinguishing the smooth from rough surface of the VASCU-GUARD patch as described in the labelled instructions for use. This is due to a deviation in the surface texture of the vascular patch in a new packaging configuration. Incorrect orientation of the patch with the rough side toward the bloodstream may increase the risk of vessel thrombosis and/or embolism.
